VOLUNTARY ANNOUNCEMENT: CORRECTION TO CIRCULAR

Oryx hereby informs Linked unitholders that an error was picked up in the Rights Issue Circular, released on the 26th of May. The error pertains to the date by which Forms of Instruction are to be lodged with Transfer Secretaries in the event that Unitholders exercise their allocated Rights in the section "**Action Required by Qualifying Unitholders in respect of Rights Issue**" on page 9 of the Circular.

The Section reads:

If you are a Qualifying Unitholder and wish to exercise all or some of the Rights allocated to you as reflected in the enclosed Form of Instruction, you may exercise your Letters of Allocation as follows:

• **EXERCISE**: You must **complete the enclosed Form of Instruction** in accordance with the instructions contained therein and lodge it, together with your EFT **proof of payment** of the aggregate Rights Issue Price payable in respect of the Rights Issue Units subscribed for, with the Transfer Secretaries so as to be received by the Transfer Secretaries by no later than close of trading on **Friday**, **07 July 2023**.

The date referred to should be **12:00 on Friday**, **14 July 2023**, as per Point 4.4 on Page 48 of the Rights Issue Circular. For ease of reference the entirety of point 4.4 is reproduced below:
